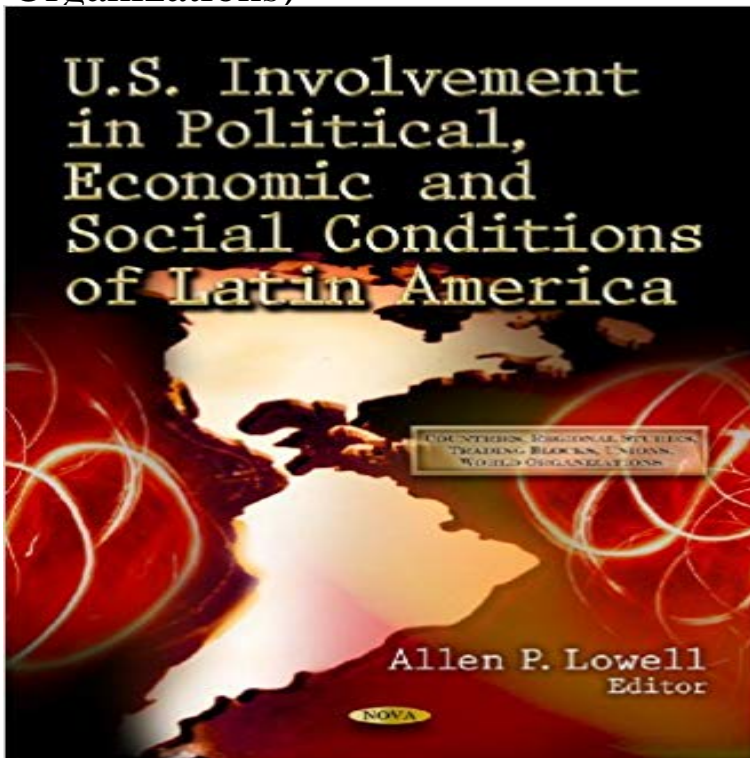


U.S. Involvement in Political, Economic & Social Conditions of Latin America (Countries, Regional Studies, Trading Blocks, Unions, World Organizations)
