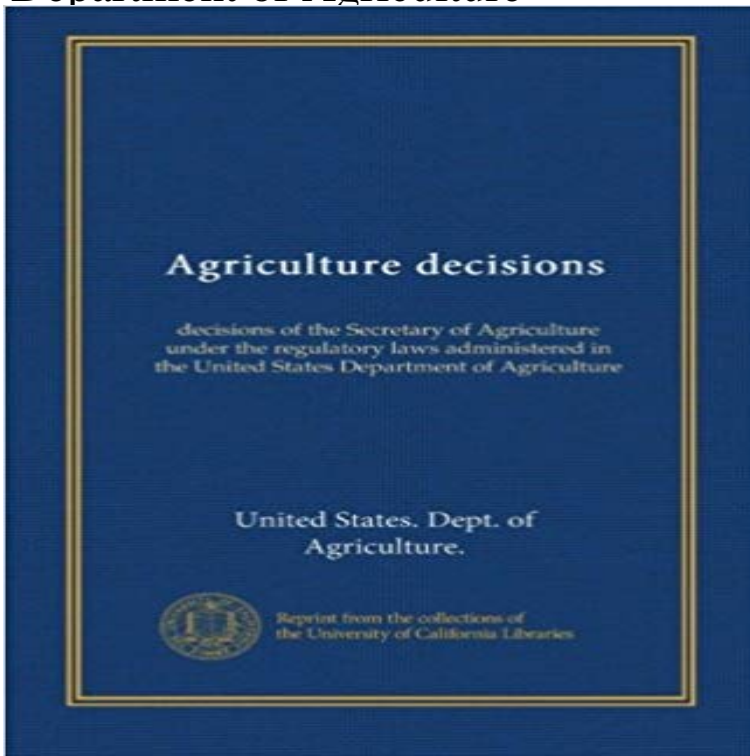


Agriculture decisions (v.40:7 1981): decisions of the Secretary of Agriculture under the regulatory laws administered in the United States Department of Agriculture
