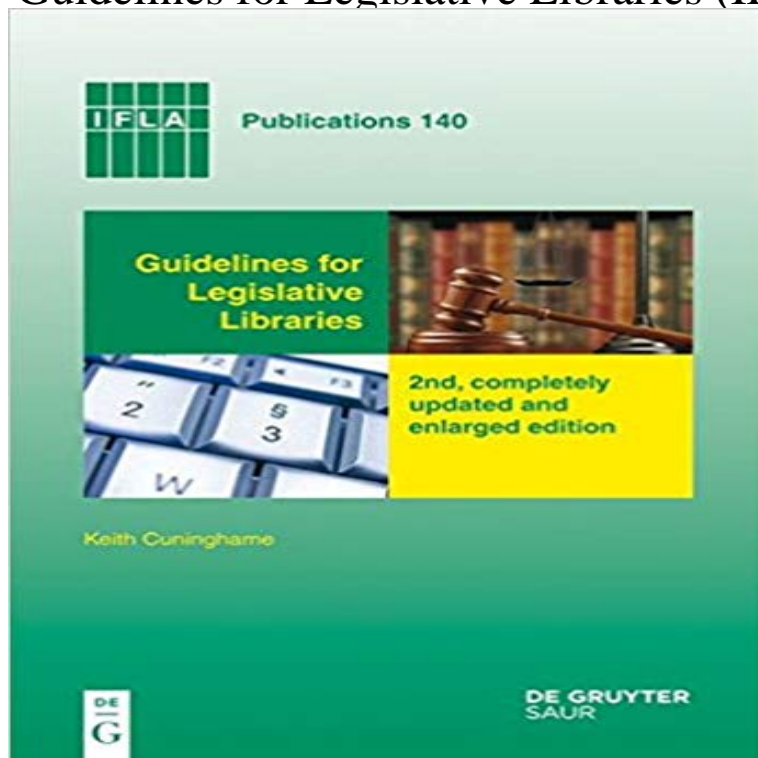


Guidelines for Legislative Libraries (IFLA Publications)
