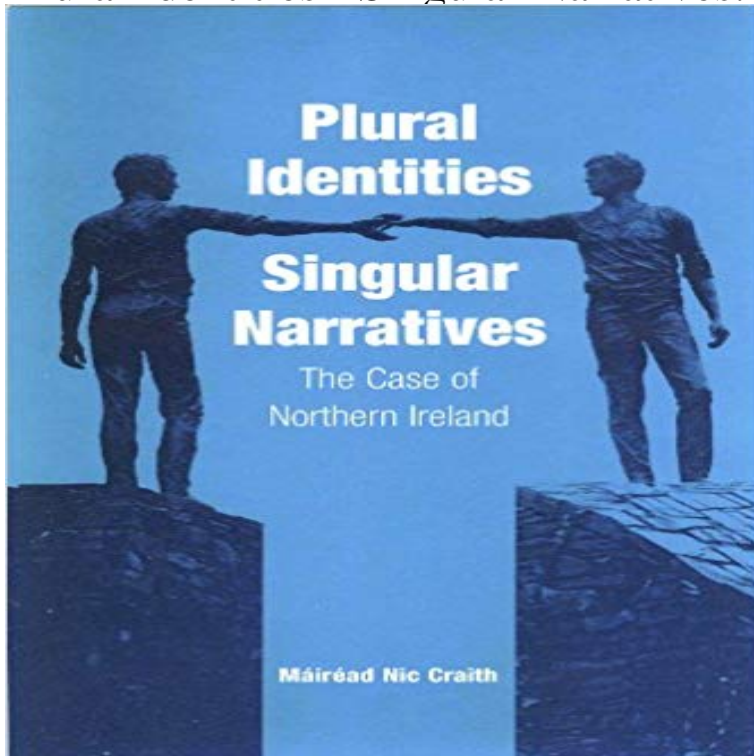


Plural Identities - Singular Narratives: The Case of Northern Ireland



Northern Ireland is frequently characterized in terms of a two traditions paradigm, representing the conflict as being between two discrete cultures.
