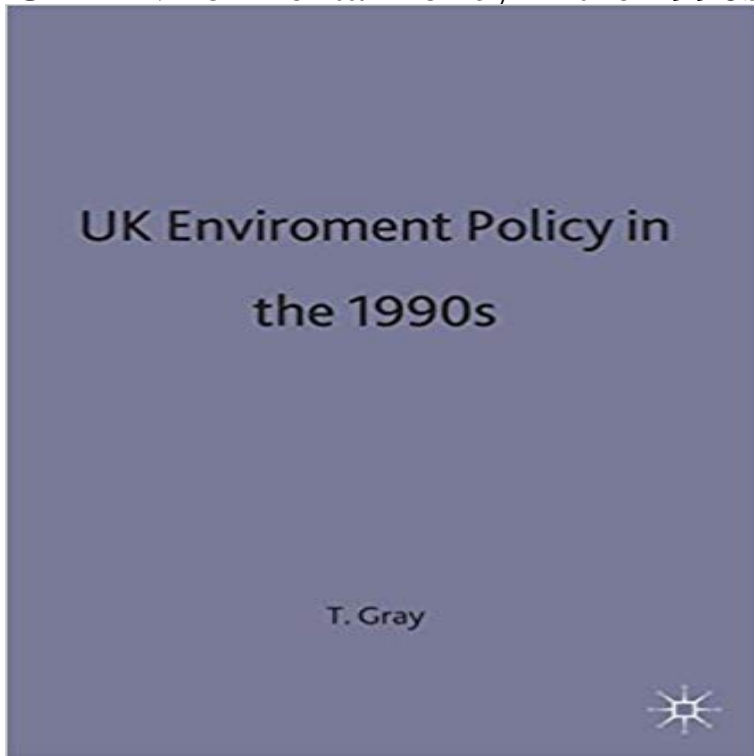


## UK Environmental Policy in the 1990s

The conclusion arrived at is mixed: in some policy areas a definite shift has occurred, but in others it is business as usual. An overall change of gear is still awaited.
