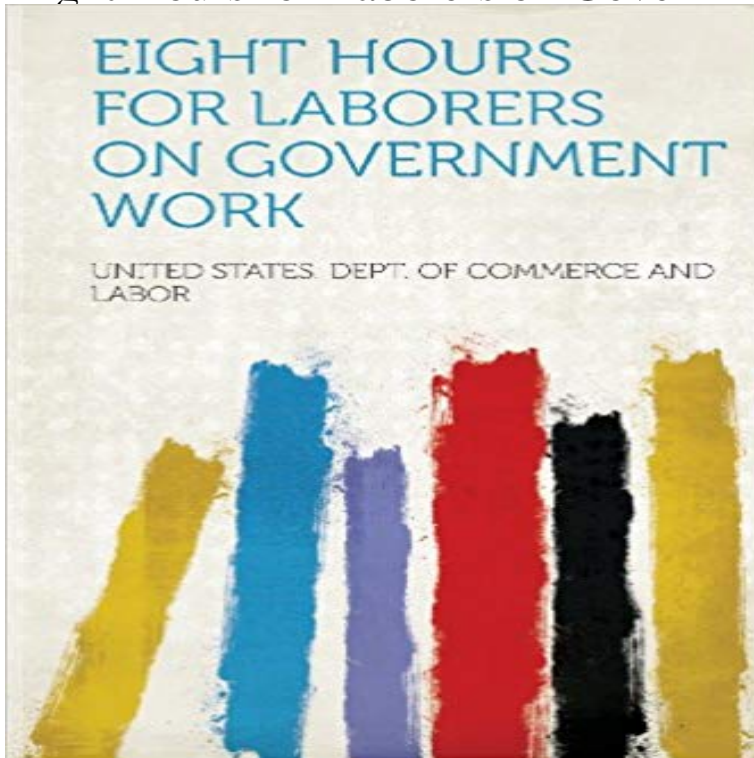


Eight Hours for Laborers on Government Work
