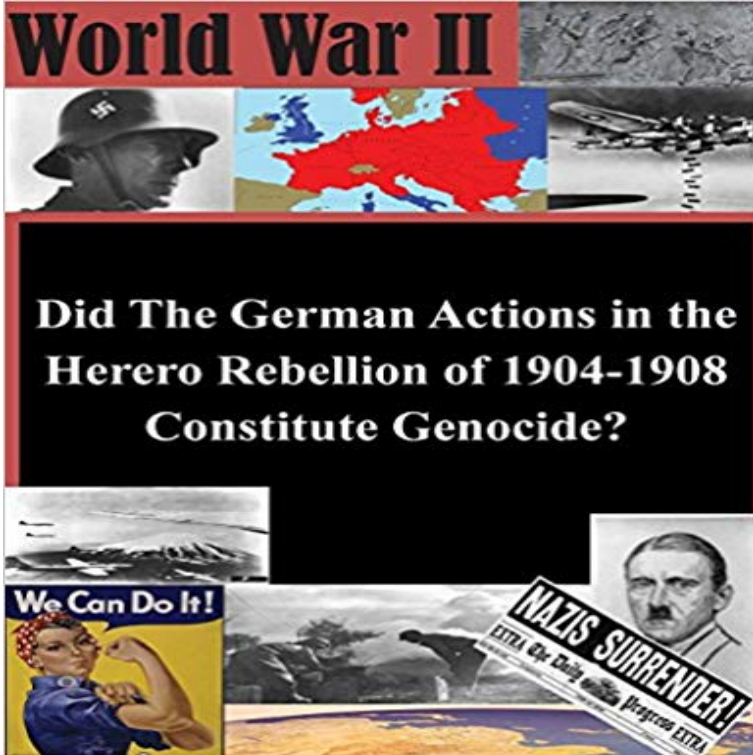


# Did The German Actions in the Herero Rebellion of 1904-1908 Constitute Genocide? (World War II)



The Herero filed lawsuit against Germany in 2001, demanding reparations for the alleged genocide during German colonialism- resuscitating a century old debate of whether the Herero Rebellion is indeed the first genocide of the twentieth century.
